This tournament is included in the Computer Ranking Scheme. Players will be ranked based on current computer rating points and ranking list when the draw takes place, no restriction on gender, based on a 1* competition.

The organising committee reserves the right to modify the group sizes in light of entries received; any amendments to times will be communicated via email.

Provisional Playing Schedule

Maximum Entry of 32 players

- 8 groups of 4 players will play a round robin format. Groups will be mixed.
- The top 2 players from each group will go into a draw to play out for a final finishing position of 1-16.
- The bottom 2 players from each group will go into a draw to play out for a final finishing position of 17-32.
- This will mean that every player, will keep playing until they get a final finishing position, regardless of whether they have won or lost their previous round.
- Based on a maximum entry, all players will be guaranteed 7 singles matches

Registration and practise from 8.15am, with play to commence at 9.00am

Tournament Regulations and Information

- 1. Every entrant must be affiliated as a Compete Member or be a member of another National Association in membership of the ITTF.
- 2. TTE Regulations Part A (Regulated Competitions) and Part B (Tournament Regulations) apply to the tournament.
- 3. ITTF Regulations for International Competitions apply to the tournament except where otherwise specified in TTE Regulations Parts A or B, or in this form.
- 4. Completion and submission of this Entry Form signifies agreement by the Entrant to the Conditions of the Competition including any variations of ITTF regulations and must be sent to amy.blitzttc@outlook.com. Full payment at point of entry will be required to secure your entry. Entries received with no payment will not be entered.
- 5. The competition is open to a maximum of 32 players. Groups mixed between boys/girls.
- 6. All matches shall be the best of five games. The final order of a group shall be determined as per ITTF regulation 3.7.5 for group competitions.
- 7. Playing clothing shall consist of a shirt and shorts, trousers, leggings or skirt, or a one-part sports outfit, socks and playing shoes; a sports hijab may also be worn. Other garments shall not be worn during play except with the permission of the referee. The main colour of a shirt, shorts, trousers or skirt, other than sleeves and collar of a shirt, shall be clearly different from that of the hall in use
- 8. No competitor or official shall engage in betting on players or matches.
- 9. All competitors will be required to umpire several matches throughout the competition.
- 10. Doping shall not take place either before or during play and doping control tests may take place.
- 11. All competitors must report to the referee on arrival and should not leave the premises without first obtaining the referee's permission. Players absent when called upon to play are liable to be scratched.
- 12. Should there be insufficient entries for the competition the referee reserves the right to cancel the event. If it becomes necessary to restrict entries, priority will be given in order of receipt.
- 13. The referee's decision shall be final on a point of law and on any question arising not provided for in these regulations.
- 14. Players entering the junior singles must have been born in 2005 or later.
- 15. All entries and event details are subject to COVID-related restrictions, or protocols and Table Tennis England deem necessary. Venues used for events may impose COVID restrictions that go beyond government guidance.
- 16. All participants and attendees at Table Tennis England events are subject to Table Tennis England Codes of Conduct. Please see https://www.tabletennisengland.co.uk/about-us/safeguardung-codes-of-conduct-and-terms-of-reference/
- 17. TTE, the Organisers and the Referee will not tolerate bad language or verbal abuse of volunteers, officials, staff or venue staff, nor a failure to follow the operational directions of stewards and event staff. We will treat all such instances extremely seriously and will take disciplinary action if necessary. - 18. - 19. The UK Anti-Doping Rules apply to all persons entering an event or competition, for whichever is the longer of a) the length of their membership or licence period; or b) 12 months from the date of their participation, whether or not the entrant or licence holder is a citizen of, or resident in, the UK.
- 20. Playing conditions Joola Flash 3* white balls, 3 Joola 2000S Green Tables & 3 Donic Compact 25 Blue Tables, Donic & Joola nets and post, Lighting is general and 300 lux and a minimum of 3m high. Flooring is a general sports hall flooring. Scoring machines will be used for all matches. Court sizes will be 9m x 4.5m, with barriers surrounding each court.
- 21. Entry closing date is Friday 12th April. Draw will be made on Monday 15th April.
- 22. There will be no charge for admission. Entry forms can be downloaded from the TTE website or requested from the organiser. Clubs wishing to enter players on bulk, can do this by contacting the organiser.
- 23. Refreshments (tea/coffee/water and various drinks) and light snacks will be on sale (chocolate/crisps etc) including Amy Elaine Bakes' excellent bakes.
- 24. Car Parking is available free of charge. Toilet facilities are available, however, there are no changing or shower facilities.
- 25. Practice There will be no separate practice facilities but competitors will be allowed to practice on tables not currently in use at the discretion of the referee. Competitors will be able to practise from 8.15am onwards.
- 26. Prizes will be given to the Winner and Runner-up
