Candidates must return a consent to nomination paper and their up-to-date CV showing how they meet the requirements of the role by the same date.

Candidates can also submit an Election Statement no longer than one side of A4 paper and /

or a three-minute video by Thursday 23 May 2024.

If the election is contested, voting information will be distributed to Company Members by email on or before Wednesday 5 June 2024. Voting will take place online using the Mi-Voice weighted voting system. Company Members will be able to vote in the period between Wednesday 5 June and Wednesday 19 June, with voting closing at 17.00 (5pm) on Wednesday 19 June 2024.

The result will be announced and published on the website as soon as possible after the vote count.
