1 Introduction and Confidentiality

Table Tennis England (the trading name of English Table Tennis Association Ltd) wishes to invite Tenders from organisations who wish to provide table tennis equipment for the following national events;

- Veterans British Clubs Leagues (VBCL)
- Youth British Clubs Leagues (YBCL)
- Women's British Clubs Leagues (WBCL)

This document provides the information required for organisations to prepare quotations for this work. Organisations should not feel constrained by this brief and should feel free to add any points they think relevant to the execution of the work.

Your quote must be submitted in accordance with the instructions contained in this document. Tenders not complying with these instructions may be rejected by Table Tennis England, whose decision in the matter will be final.

All information contained in this invitation to quote is confidential. Likewise, all information included by bidders in their proposals will be treated in confidence.

Any contract resulting from the bidding process will be with Table Tennis England and will be governed and interpreted in all respects by English Law.

2. Background to Table Tennis England

Table Tennis England is the national governing body of table tennis in England, currently with over 28,000 members, many of which play competitively in clubs and competitions.

Additionally, nearly 400,000 people play table tennis at least twice a month in England, in more recreational settings.

Table Tennis England have a highly engaged, large global online following that is growing rapidly;

Table Tennis England work with a range of partners to deliver a large number of projects, programmes, competitions and events annually.

3. The British Clubs Leagues

British League is Table Tennis England's premier club competition and is open to entrants from across the Home Nations (England, Scotland, Wales, Ireland, Guernsey, Jersey and Isle of Man). There are separate competitions for Senior players, Women, Juniors and Veterans. The competitions are run by the Table Tennis England Competition and Events team, the British Clubs Leagues committee and teams of volunteers.

- Senior British Clubs Leagues (SBCL)
- Veterans British Clubs Leagues (VBCL)
- Youth British Clubs Leagues (YBCL)
- Women's British Clubs Leagues (WBCL)

YBCL, WBCL and VBCL leagues each take place at two large weekend events - one apiece in Autumn and one apiece in Spring - where all teams gather together at a single national venue and play their league fixtures in two blocks. SBCL, takes on a different format and therefore is not part of this Tender process.

Depending on the entrants received for specific competitions, we may require a wheelchair compliant table as part of the specified quantity, included within the numbers above.

In addition to the supply of equipment, organisations tendering for this contract are invited to make donations towards the running of events, to cover prize money etc.

5. Equipment Specifications

The supplied equipment must all be International Table Tennis Federation approved.

Additionally, ITTF approved equipment should be in good, working order, free from any major scratches or gouges. Tables will be required to be cleaned prior to practice which starts at 8am on Saturday mornings.

6. Additional opportunities, rights and benefits

Subject to agreement, the organisation who wins the tender to supply the equipment for the events listed in this document will have;

- 1) The right to use the title "Official Equipment Supplier to Table Tennis England" in advertising, promotions, literature, PR etc worldwide for the term of the agreement, but not exclusively.
- 2) A sales stand at the event at a location determined by Table Tennis England
- 3) Acknowledgement on any relevant Table Tennis England event programmes and related printed publications and on the relevant page of the Table Tennis England and British Clubs Leagues websites
- 4) If produced, a page advert in the Table Tennis England event programme whether printed or digital. This needs to be supplied a minimum of two weeks prior to the event.
- 5) Banners/surrounding bearing the supplier's brand (and/or the equipment brand) for a 5 x 3 space court. For example, the equipment supplier will be entitled to 2 banners per court (produced at their own cost). Other banners will feature either Table Tennis England branding, sponsor branding or be blank, at the discretion of Table Tennis England.
- 6) 2 VIP invitations on a limited basis to civic receptions and other social occasions associated with the event should any such events take place. Note; Other advertising spaces on extra equipment such as skirt around the table, towel boxes are outside this agreement

Events may also be streamed live and covered across social media, website and through email communications.

All organisations tendering for this contract, are invited to apply for Title Sponsorship for the event. This will be subject to separate negotiation and agreement.

6.5 Marketing and Sponsorship Opportunities (Optional and Costed)

In addition to the core rights and benefits, Table Tennis England offers a range of *optional*, *costed* marketing and brand activation opportunities designed to enhance visibility, drive engagement, and maximise the value of association with our national events.

These opportunities sit outside the direct supply agreement and will be subject to separate negotiation. Organisations tendering for this contract are encouraged to express interest in any of the following within their tender response:

- Title Sponsorship Organisations are invited to apply for **Title Sponsorship** of the listed events. This prestigious opportunity includes prominent brand exposure, enhanced rights packages, and deep integration across marketing and event channels. This will be agreed separately with any interested party.
- **Editorial** with **Promotion** Feature Integrated A dedicated editorial feature on tabletennisengland.co.uk, co-created with our team to tell your brand story, highlight your product, and drive action through embedded advertising and call-to-actions. Timing can be aligned with major events for maximum exposure.
- **Direct Communications** to Contactable Database Access to over 130,000 opted-in contacts via dedicated email marketing opportunities. These can be used to promote exclusive offers, product campaigns or brand-led initiatives, in line with Table Tennis England's content and brand standards.
- Social Media Content Activations Co-branded content opportunities across Table Tennis England's digital channels, which reach a combined audience of more than 110,000 followers. Activations can be planned around key event moments, product placements or campaign themes.

These brand opportunities will be developed and costed in partnership with Table Tennis England's Brand & Communications team. All deliverables, timelines, and commercial terms will be scoped and agreed separately with the successful supplier.

7. Assessment of Tenders

You should email a copy of the completed Submission Form to tenders@tabletennisengland.co.uk by 12noon on Monday 7th July 2025.

Following a full review of the Submission Forms, a decision will be made to appoint the successful organisations or invite a shortlist of suppliers to make a formal presentation of their proposal at which time a selection panel from Table Tennis England may have further questions to which they will require answers. If interviews are required, details will be agreed with suppliers once the tenders have been assessed.

Please provide a statement of no more than 400 words for each evaluation criteria detailing evidence of previous success/experience and how you propose to fulfil each of the elements of the Specification, taking account of the requirements shown above.

80% of the maximum weighted score will be available from the assessment of Quotes against the Quality Criteria shown above. The remaining 20% will be available from the assessment of the price.

The successful bidders will be the one who, in the opinion of Table Tennis England at the conclusion of the evaluation, offers the Most Economically Advantageous Tender (MEAT) to Table Tennis England having regard to both the quality, service and price award criteria.
