1 Introduction and Confidentiality

Table Tennis England (the trading name of English Table Tennis Association Ltd) wishes to invite Tenders from organisations who wish to provide table tennis equipment for the following national events;

This document provides the information required for organisations to prepare quotations for this work. Organisations should not feel constrained by this brief and should feel free to add any points they think relevant to the execution of the work.

Your quote must be submitted in accordance with the instructions contained in this document. Tenders not complying with these instructions may be rejected by Table Tennis England, whose decision in the matter will be final.

All information contained in this invitation to quote is confidential. Likewise, all information included by bidders in their proposals will be treated in confidence.

Any contract resulting from the bidding process will be with Table Tennis England and will be governed and interpreted in all respects by English Law.

2 Background of Table Tennis England

Table Tennis England is the national governing body of table tennis in England, currently with over 28,000 members, many of which play competitively in clubs and competitions.

Additionally, nearly 400,000 people play table tennis at least twice a month in England, in more recreational settings.

Table Tennis England have a highly engaged, large global online following that is growing rapidly;

Table Tennis England work with a range of partners to deliver a large number of projects, programmes, competitions and events annually.

3 The National Events

All of our national events will be taking place centrally within England for players across England to take place in these events. Should a venue change happen, we will communicate to all supplies once it is confirmed.

Mark Bates Ltd, Senior national Qualification

This event is open to all players who are eligible to play for England, who want to take part in the National Qualifying tournament. They will all be competing for a top 14 finish, as the top 14 men and women from this competition will be invited to the Mark Bates Ltd Senior National Championships.

Mark Bates Ltd, Senior National Championships

The best players in the country, including Olympians, Paralympians and Commonwealth Champions will battle it out in Men's and Women's Singles and Doubles as well as Para events, for the right to be called National Champions.

Mark Bates Ltd, Junior & U21 National Championships

This competition sees the best 32 players, based on Table Tennis England Rankings, invited to compete amongst each other singles and doubles across all age groups to be crowned the National Champion.

Mark Bates Ltd, Cadet & U17 National Championships

This competition sees the best 32 players, based on Table Tennis England Rankings, invited to compete amongst each other singles and doubles across all age groups to be crowned the National Champion.

Mark Bates Ltd, U10-13 National Championships

This event is open to all players who are eligible to play for England, who want to take part in the National Championships, with protected entries for those in the top 16 rankings. This competition incorporates the four age brackets for singles with doubles in both U12's and U13's.

In addition to the supply of equipment, organisations tendering for this contract are invited to make donations towards the running of events, to cover prize money etc.

5 Equipment Specifications

The supplied equipment must all be International Table Tennis Federation approved.

Additionally, ITTF approved equipment should be in good, working order, free from any major scratches or gouges. Tables will be required to be cleaned prior to practice which starts at 8am on Saturday mornings.

6 Additional opportunities, rights and benefits

Subject to agreement, the organisation who wins the tender to supply the equipment for the events listed in this document will have;

- 1) The right to use the title "Official Equipment Supplier to Table Tennis England" in advertising, promotions, literature, PR etc worldwide for the term of the agreement but not exclusively.
- 2) A sales stand at the event at a location determined by Table Tennis England
- 3) Acknowledgement on any relevant Table Tennis England event programmes and related printed publications and on the relevant page of the Table Tennis England websites
- 4) If produced, a page advert in the Table Tennis England event programme whether printed or digital. This needs to be supplied a minimum of two weeks prior to the event.
- 5) Banners/surrounding bearing the supplier's brand (and/or the equipment brand) for a 5 x 3 space court. For example, the equipment supplier will be entitled to 2 banners per court (produced at their own cost). Other banners will feature either Table Tennis England branding, sponsor branding or be blank, at the discretion of Table Tennis England.
- 6) 2 VIP invitation on a limited basis to civic receptions and other social occasions associated with the event should any such events take place.

Note; Other advertising spaces on extra equipment such as skirt around the table, towel boxes and umpire tables are outside this agreement

Events may also be streamed live and covered across social media, website and through email communications.

Social Media Content Activations

Co-branded content opportunities across Table Tennis England's digital channels, which reach a combined audience of more than **110,000 followers**. Activations can be planned around key event moments, product placements or campaign themes.

These brand opportunities will be developed and costed in partnership with Table Tennis England's Brand & Communications team. All deliverables, timelines, and commercial terms will be scoped and agreed separately with the successful supplier.

Following a full review of the Submission Forms, a decision will be made to appoint the successful organisations or invite a shortlist of suppliers to make a formal presentation of their proposal at which time a selection panel from Table Tennis England may have further questions to which they will require answers. If interviews are required, details will be agreed with suppliers once the tenders have been assessed.

Please provide a statement of no more than <u>400 words</u> for each evaluation criteria detailing evidence of previous success/experience and how you propose to fulfil each of the elements of the Specification, taking account of the requirements shown above.
