1. Entries along with PAYMENT must be RECEIVED by email info@worthingttc.com by no later than 27th March 2025
2. The Draw will be held on 28th March 2026
3. If it becomes necessary to restrict entries, priority will be given in order of receipt.
4. Payment must be made by bank transfer by the closing date (or immediately for late entries).

6. hot and cold drinks is available on site. There is ample free parking and toilets, changing rooms and shower facilities are available at the venue.
7. Butterfly R40 white balls will be used.
8. Play will take place on up to 12 Tibhar Smash Green Tables , with Tibhar Smash Net and post sets and Tibhar Scoring Machines.
9. Tables will be individually courted. Minimum ceiling height: 7m; Minimum Court Size: 9m X 4.5m.
10. Lighting is general & fluorescent lighting. Minimum light intensity is 500 lux. Minimum height of lighting: 7m.
11. The venue has wooden sprung flooring.
12. There will be no admission charge.
13. Competitors will be informed by email that their entry has been received within 1 day of the entry being received and a confirmation email with more details will be sent out 2 days before the event. If you do not receive this, please get in touch with Sally Hughes.
14. No refunds are possible after the closing date under any circumstances.
15. The planned format is progressive KO, teams will continue to play till there is a finished ranking from 1-32. each team game will follow 1V1, 2v2, where the score is 1-1 the two losers will play to determine a winner.
16. Only the players/coach named on the match card for the match in question will be permitted to give advice
17. Definition of each category is: Juniors – born in 2007 or later,
18. Winner and Runners Up will receive a medal.
19. The results from this tournament will qualify for computer ranking points.
20. All entries and event details are subject to COVID-related restrictions, or protocols that Table Tennis England may deem necessary. Venues used for events may impose COVID restrictions that go beyond government guidance.

TOURNAMENT REGULATIONS

- TTE Regulations Part A (Regulated Competitions) and Part B (Tournament Regulations) apply to the tournament.
- ITTF Regulations for International Competitions apply to the tournament except where otherwise specified in TTE Regulations Parts A or B, or in this form.
- Every entrant must be affiliated as a Compete Plus Member or provide proof of being a member of another National Association affiliated to the ITTF and pay the appropriate fee in order to gain a reciprocal membership. An entrant who is not a TTE member or is affiliated as a Supporter or Club Play Member may alternately purchase a One-Off Tournament Pass at the time of entry via <https://tabletennisengland.sport80.com/> once this product is launched. An entrant only affiliated as a Compete member may enter the tournament upon payment of the appropriate One- Time Tournament Top-Up fee via <https://tabletennisengland.sport80.com/> It is not possible to obtain the OTTP or the OTTT at the tournament"
- Completion and submission of this entry form signifies agreement by the entrant to the conditions of the competition including any variations of ITTF regulations.
- All matches shall be the best of five games up to 11. The final order in a Group shall be decided as per ITTF Regulation 3.7.5.
- Competitors must report to Control on arrival and must not leave the hall without obtaining permission. Players absent when called upon to play are liable to be scratched.
- The Organiser reserves the right to merge/cancel events if entries are low.
- There will be no separate practice facilities, but competitors will be permitted to practice on match tables at the discretion of Control.
- All competitors may be required to umpire at least one match in each event entered.
- Playing clothing shall consist of a shirt and shorts, trousers, leggings or skirt, or a one-part sports outfit, socks and playing shoes; a sports hijab may also be worn. Other garments shall not be worn during play except with the permission of the referee. The main colour of a shirt, shorts, trousers or skirt, other than sleeves and collar of a shirt, shall be clearly different from that of the ball in use. Any markings or trimming on the front or side of a playing garment and objects such as jewellery worn by a player shall not be so conspicuous or brightly reflecting as to unsight an opponent.
- Doping shall not take place either before or during play. Doping Control tests may take place.
- No gluing up or boosting/tuning will be allowed.
- No competitor or official shall engage in betting on players or matches.
- Match results will be submitted for inclusion in the Table Tennis England computer ranking scheme
- Photo/livestreaming Worthing Table Tennis club may be taking photos and live streaming matches during this event which may include (but not limited to), using them in our printed and online platforms, social media, press releases and funding applications. If you do not give permission to take photographs and/or video of you (or individuals for whom you are legally responsible), please contact (organisation email) Please be aware that we follow the Table Tennis England's Photo and live streaming Policy.
