## TOURNAMENT REGULATIONS AND INFORMATION

1. Every entrant must be affiliated as a Compete Member or provide proof of being a member of another National Association in membership of the ITTF in order to gain a reciprocal membership. An entrant who is not a TTE member or is affiliated as a Supporter or Club Play Member may alternately purchase a One-Off Tournament Pass at the time of entry via <https://tabletennisengland.sport80.com/> once this product is launched. It is not possible to obtain the OTTP at the tournament.
2. TTE Regulations Part A (Regulated Competitions) and Part B (Tournament Regulations) apply to the tournament.
3. ITTF Regulations for International Competitions apply to the tournament except where otherwise specified in TTE Regulations Parts A or B, or in this form.
4. The competition is open to a maximum of 30/32 players, and group sizes based on entrants, groups may be mixed between male/female if there are Insufficient entrants.
5. All matches shall be the best of five games. The final order in a group shall be determined as per ITTF regulation 3.7.5 for group competitions. All competitors may be required to umpire at least one match in each event entered.
6. Main colour of clothing must be different from colour of ball.
7. No competitor or official shall engage in betting on players or matches.
8. Completion and submission of this Entry Form signify agreement by the entrant to the conditions of the competition, including any variations of ITTF regulations, and must be sent to [jschoi646@gmail.com](mailto:jschoi646@gmail.com). Full payment at point of entry will be required to secure your entry. Entries received with no payment will not be entered.
9. Playing conditions – Tibhar SL 3\* white balls, five Cornilleau 840 wood tables and nets, LED lighting is general and 500 lux. Floor to ceiling and floor to lighting height is approximately 4 metres. Flooring in hall is Vinyl. Scoring machines and TIBHAR umpire tables will be used for all matches. Court sizes will be 10m x 4m, with barriers surrounding each court.
10. No entry will be accepted after the draw has been made, subject to the discretion of the Referee.
11. All entries and event details are subject to COVID-related restrictions, or protocols that Table Tennis England may deem necessary. Venues used for events may impose COVID restrictions that go beyond government guidance.
12. All participants and attendees at Table Tennis England events are subject to Table tennis England Codes of Conduct. See [here](#)
13. TTE, the Organisers and the Referee will not tolerate bad language or verbal abuse of volunteers, officials, staff or venue staff, nor a failure to follow the operational directions of stewards and event staff. We will treat all such instances extremely seriously and will take disciplinary action if necessary. For further details, please see the Table Tennis England [Workforce Protection Policy](#)

15. Entry closing date Sunday 24<sup>th</sup> May 2026 5pm. Draw will be made on Friday 5<sup>th</sup> June 2026 and will be posted on the day of the tournament.

16. If it becomes necessary to restrict entries, priority will be given in order of receipt. You are encouraged to enter early to avoid disappointment.
17. In conjunction with the TTE Child Protection Policy, persons wishing to take photographs or video images must register with the event organiser, producing their professional identification, TTE authorisation or a completed TTE authorisation form which can be obtained from the organiser.
18. All competitors will be required to book in upon their arrival, should not leave the centre hall without notifying the referee. Players absent when due to play are liable to be scratched from their next match. Practice will only be permitted prior to event starting.
19. The referee's decision shall be final on a point of law and on any question arising not provided for in these regulations, or in any dispute as to the interpretation thereof.
20. There will be no charge for admission. Entry forms can be downloaded from the TTE website or requested from the organiser.
21. Changing facilities will be available, including showers.
22. Street parking is available in Dukes Avenue.
23. Doping shall not take place either before or during play and doping control tests may take place.
24. Light refreshments will be on sale.
25. All group winners will receive a £30 BRIBAR voucher, Runners Up will receive a £20 BRIBAR voucher and players finishing in 3<sup>rd</sup> place will receive a consolation prize.
26. Players must have been born in 2015 or later.
