Entry and payment can also be made on our website www.matrixtt.co.uk subject to an admin fee.

TOURNAMENT INFORMATION

1. Entries along with PAYMENT must be RECEIVED by email to Joe Britnell no later than 10th April 2027
2. The Draw will be held on 10th April 2027 and will not be available until day of event.
3. If it becomes necessary to restrict entries, priority will be given in order of receipt.
4. Payment must be made by bank transfer by the closing date (or immediately for late entries).

6. Free car parks, toilets, changing rooms and shower facilities are available at the venue.
7. A selection of hot and cold drinks, hot food and snacks will be available to purchase at the venue.
8. Tibhar 3* White balls will be used.
9. Play will take place on 8 Tibhar smash 22 Tables with Tibhar Nets and Posts, and with Tibhar Scoring Machines
10. Tables will be individually courted. Minimum ceiling height: 4m; Minimum Court Size: 9m x 5m
11. Lighting is general. Minimum height of lighting: 3.6m.
12. The venue has Gerflor Plastic Classic flooring.
13. There will be no admission charge.
14. Competitors will be informed by email that their entry has been received within 3 days of the entry being received and a confirmation email with more details will be sent out on the closing date of the event. If you do not receive this, please get in touch with Joe Britnell
15. No refunds are possible after the closing date under any circumstances, late entries will be accepted however will be subject to a £5 late entry fee.
16. The events are: Senior Men's Open and Women's Singles groups with knockout
17. Winner and runners up will receive a trophy and a share of the prize pot of £300. Each event winner will take £100 and runner up will receive £50. If events are merged due to lack of entries in one category then the pot is £200 split between £130 winner and £70 runner up.
18. The results from this tournament will qualify for computer ranking points.
19. Format for all events will be groups of 6 followed by knockout. So, if full entry of players, each player is guaranteed 5 matches.
20. All entries and event details are subject to COVID-related restrictions, or protocols that Table Tennis England may deem necessary. Venues used for events may impose COVID restrictions that go beyond government guidance.
21. All participants and attendees at Table Tennis England events are subject to Table Tennis England Codes of Conduct. See [here](#)
22. TTE, the Organisers and the Referee will not tolerate bad language or verbal abuse of volunteers, officials, staff or venue staff, nor a failure to follow the operational directions of stewards and event staff. We will treat all such instances extremely seriously and will take disciplinary action if necessary. For further details, please see the Table Tennis England [Workforce Protection Policy](#).
23. A variety of food and hot meal options will be available on the day for a fee.

TOURNAMENT REGULATIONS

1. TTE Regulations Part A (Regulated Competitions) and Part B (Tournament Regulations) apply to the tournament.
2. ITTF Regulations for International Competitions apply to the tournament except where otherwise specified in

TTE Regulations Parts A or B, or in this form.

3. Every entrant must be affiliated as a Compete Plus Member or provide proof of being a member of another National Association affiliated to the ITTF and pay the appropriate fee in order to gain a reciprocal membership. An entrant who is not a TTE member or is affiliated as a Supporter or Club Play Member may alternatively purchase a One-Off Tournament Pass at the time of entry via <https://ttehub.com/> once this product is launched. An entrant only affiliated as a Compete member may enter the tournament

upon payment of the appropriate One- Time Tournament Top-Up fee via <https://ttehub.com/>. It is not possible to obtain the OTTP or the OTTT at the tournament.

4. Completion and submission of this entry form signifies agreement by the entrant to the conditions of the competition including any variations of ITTF regulations.

5. All matches shall be the best of five games up to 11. The final order in a group shall be decided as per ITTF

Regulation 3.7.5.

6. Competitors must report to Control on arrival and must not leave the hall without obtaining permission. Players absent when called upon to play are liable to be scratched.

7. The Organiser reserves the right to merge/cancel events if entries are low.

8. There will be no separate practice facilities, but competitors will be permitted to practice on match tables at the discretion of Control.

9. All competitors may be required to umpire at least one match in each event entered. All competitors will be scheduled to umpire via the playing schedule group sheet.

10. Playing clothing shall consist of a shirt and shorts, trousers including tracksuit bottoms, leggings or skirt, or a one-part sports outfit, socks and playing shoes; a sports hijab may also be worn. Other garments shall not be worn during play except with the permission of the referee. The main colour of a shirt, shorts, trousers or skirt, other than sleeves and collar of a shirt, shall be clearly different from that of the ball in use. Any markings or trimming on the front or side of a playing garment and objects such as jewellery worn by a player shall not be so conspicuous or brightly reflecting as to unsight an opponent.

11. Doping shall not take place either before or during play. Doping Control tests may take place.

12. No gluing up or boosting/tuning will be allowed.

13. Time outs are permitted only in knock out rounds.

14. No competitor or official shall engage in betting on players or matches.

15. Match results will be submitted for inclusion in the Table Tennis England computer ranking scheme

16. Photo/livestreaming, Matrix TT may be taking photos and live streaming matches during this event which may include (but not limited to), using them in our printed and online platforms, social media, press releases and funding applications.
