

Table Tennis England Mr Bean Giveaway Terms and Conditions

Organiser and Promoter

This competition is organised and promoted by Table Tennis England, Loughton Lodge, Bradwell Road, Milton Keynes, MK8 9LA.

Eligibility

Entry is open to residents of the United Kingdom who have any active **2026/27 Table Tennis England membership** by the competition closing date.

Participants under the age of 18 must have the consent of a parent or legal guardian to enter.

Employees of Table Tennis England, their immediate family members and members of their household are not eligible to enter.

Nature of the Competition

This competition is a free prize giveaway. One eligible entrant will be selected to receive a Mr Bean prize bundle.

Entry Method

To enter, participants must:

2. Hold an active 2026/27 Table Tennis England membership by the competition closing date.

No purchase is necessary other than any applicable Table Tennis England membership fee associated with the entrant's chosen membership category. Free membership categories are available.

Competition Period

The competition opens on **11 September 2026** and closes at **5:00pm on 30 September 2026**.

Entries submitted after the closing time will not be accepted.

Winner Notification

The winner will be contacted using the email address provided on the competition entry form.

The winner must respond and claim their prize within **seven days** of being notified.

If the winner does not respond within seven days, cannot be contacted, does not satisfy the eligibility requirements or declines the prize, Table Tennis England reserves the right to withdraw the prize and select another eligible winner at random.

Prize Delivery

Table Tennis England will arrange delivery of the prize bundle with the confirmed winner.

The winner may be required to provide a valid UK postal address for delivery of the prize. Table Tennis England will not be responsible for a prize being

delayed or undelivered as a result of incorrect or incomplete delivery information supplied by the winner.

Data Protection and Marketing
